How to leave a gift in your will

There a number of different ways to leave money to charity in your will and we strongly recommend that you talk to a solicitor to draw up or amend your will so they can advise you on the best approach and ensure that your wishes are met.



To leave a gift to QVH, you may suggest the following wording to your solicitor:

I leave [percentage/fraction or fixed sum of residuary estate] to The Queen Victoria Hospital NHS Trust Charitable Fund, Queen Victoria Hospital, Holtye Road, East Grinstead, West Sussex RH19 3DZ, registered charity number 1056120.

Your gift can make a real difference

Donations from legacies enabled the hospital to buy a £50,000 state-of-the-art laser for removing skin and mouth cancers. The very precise equipment removes diseased tissue without the need for more invasive surgery. This protects surrounding healthy tissue and helps patients to heal faster.
